\_\_\_ **COMPLETED BEACH APPLICATION (one application per family).**

\_\_\_ **A STAMPED-SELF ADDRESSED ENVELOPE.**

\_\_\_ **A CURRENT and LEGIBLE photocopy of each vehicle registration.** If vehicle registration does not show the name and address of resident, applicant must ALSO attach either a photocopy of the insurance card or a photocopy of the first page of the vehicle lease showing resident's name and Rowayton address. This is regardless of where vehicle is registered.

\_\_\_ **APPLICATION FEE:** \$10.00 entitling each resident to one parking permit + \$5.00 for each additional parking permit to be paid by check payable to the Sixth Taxing District (6TD).

\_\_\_ **RENTER:** A copy of 1<sup>st</sup> page of current lease showing resident's name and Rowayton address.

\_\_\_ **NON-RESIDENTS WHO OWN RESIDENTIAL PROPERTIES IN ROWAYTON:** A copy of the current, paid property tax bill and registration for one vehicle.

\_\_\_ **LATE FEE:** All applications **POSTMARKED AFTER MONDAY, MAY 31, 2011** must be accompanied by a \$25.00 late fee in addition to the \$10.00 application fee + \$5.00 for each additional parking permit. Exceptions: new vehicle registrations obtained after original permit and residents new to Rowayton after April 15<sup>th</sup>.
